

## **Privacy Policy**

Prosperous Play US, LLC ("Prosperous Play"), is the operator of the website <https://www.Midasjackpots.com/> (the "Website"), and all subdomains, subpages and successor sites features, tools and services available thereon (the "Services"). This Privacy Policy details how we manage, collect and use your information obtained through your use of our Services. All information you provide through your use the Website is subject to the terms of this Privacy Policy.

### **What Type Of Information We Collect**

We collect un-identified and non-identifiable information, which may be made available or gathered via your use of the Services and/or interactions with the Website ("Non-personal Information"). We are not able to identify you from Non-personal Information that is collected.

In order to enhance the functionality of the Services and to provide you with a better user experience, we collect technical information transmitted by your computer (through the use of third party analytical cookies), including certain software and hardware information (e.g. the type of browser and operating system your device uses, language preference, access time and the domain name of the website from which you linked to the Services; etc.).

We also collect information about your use of the Services, such as user activity (e.g. pages viewed, the amount of time spent on particular pages, online browsing, clicks,

actions, etc.). This information is collected for research and analytics purposes regarding your use of the Services.

We may also conduct research on our user demographics, interests and behavior. We aggregate, anonymize or de-identify the information collected by the Services or via other means so that the information cannot, on its own, personally identify you. We may share this aggregated and/or de-identified data with our affiliates, agents and business partners. We may also disclose aggregated and/or de-identified user statistics and other metrics related to our Website in order to describe our products or services to current and prospective business partners and to other third parties for other lawful purposes.

We also collect personally identifiable information, namely information that identifies you including, without limitation, (i) full name; (ii) mailing/residential address; (iii) phone number; (iv) email address; (v) age; (vi) information we obtain from a third party about your use of or interest in our Services; (vii) transaction information you provide when you make a purchase and/or request a redemption, including banking, financial, and/or other payment method details, and bank account statements and/or (viii) location information, including, without limitation, location information provided by a mobile or other device interacting with the Website, or associated with your IP address. ("Personal Information"). We may also request other forms of Personal Information in order to ensure your compliance with our Terms and Conditions and/or verify your eligibility to participate in the Services.

All Personal Information shall be as accurate, complete, and up-to-date as is necessary for the purposes for which it is used. It shall be your sole responsibility to update any and all Personal Information provided for use of the Website.

If we combine Personal Information with Non-personal Information, the combined information will be treated as Personal Information for as long as it remains combined.

## **Cookies**

We use cookies and other technologies to gather, store, and track certain information related to your use of the Services.

A cookie is a piece of data stored on your computer containing information about your access to the Website. Cookies may be sent by us or our third-party vendors. Each user can set its browser to notify the user before a cookie is received, giving an opportunity to decide whether to accept the cookie. Each user may also set its browser to turn off cookies; however, some features of the Website may not work properly in such instance.

We and our trusted partners may use such cookies for various different purposes. These purposes include allowing you to navigate between pages efficiently, enable automatic activation of certain features, remembering your preferences, and making the interaction between you and our Services quicker and easier.

By using our Services and/or otherwise accessing the Website, you agree to the use and storage of cookies on your computer or device. ## **How We Use The Information We Collect**

- Where you have given us your specific consent for processing your information.

The type of Personal Information collected and the purposes listed above are necessary for our legitimate business interests including, without limitation, to develop our products and services, grow our business, study how visitors use our services and inform our marketing strategy).

## **Sharing of Personal Information**

We do not trade, sell, or otherwise share your Personal Information with third-parties except as set out in this Privacy Policy. In addition to the different uses listed above, we may transfer or disclose Personal Information to other third parties for any of the following reasons:

- For the purpose of processing payments, conducting quality assurance testing, geo-locating users, personalizing and improving your use and experience of the Website, sending email and push notifications, enabling security support and technical maintenance, and preventing harmful and/or unlawful uses of the Website.
- For analytics purposes and website performance.
- We reserve the right to disclose to third parties information about users for marketing analysis and/or to our advertisers and advertising networks; however, any information disclosed will be in the form of aggregate data that does not describe or identify an individual user.
- We may disclose Personal Information, or any information you submitted via the Service if we have a good faith belief that disclosure of such information is helpful or reasonably necessary to: (i) comply with any applicable law, regulation, legal process or governmental request; (ii) investigate, detect, prevent, or take action regarding illegal activities or other wrongdoing, suspected fraud or security issues; (iii) to establish or exercise our rights to defend against legal claims; (iv) prevent harm to the rights, property or safety of us, our users, yourself or any third party; or (v) for the purpose of collaborating with law enforcement agencies.

· In the event that ownership of all or a part of Prosperous Play or its business were to change via merger, acquisition, divestiture, dissolution, or sale of all or substantially all of Prosperous Play's assets.

We do not allow our third-party service providers to use your Personal Information for their own purposes and only allow them to process your Personal Information for specific purposes and in accordance with our instructions or required by law.

### **Third Party Services and Collection Of Information**

Third parties may provide materials to the Website that use cookies, web beacons, or other tracking technologies to collect your information, including information about your online activities over time and across different websites and other online services. Those third parties may use this information to provide you with interest-based advertising or other targeted content. We do not control third party tracking technologies or how third parties use them. Your use of third party applications or services are governed by the user terms and privacy policy of the third party that provided that application or service. This Privacy Policy does not apply to any third party's websites, services or applications, even if they are accessible, downloadable, or otherwise distributed through the Services.

When you initiate a payment transaction through the Website, we may process your payments through a third party website, including, without limitation, third-party payment processors. The third party website may collect certain financial information from you in order to process a payment, including your name, email address, address and other billing information.
